CONDITIONS FOR LEASED MEMBERSHIP PLAYING RIGHTS

1. Leasees may only apply for Full Playing Rights.
2. If a leasee does not wish to continue their lease beyond the current financial year, they must advise Thirteenth Beach Golf Links in writing by June 30. If notice is not received a pro-rata subscription will be charge for the following financial year.
3. Leasees may only lease for a period no longer than three years. This excludes the leasee from applying to then lease another membership under another shareholding.
4. Subscription notices will be sent to the leasee, however, the shareholder will be liable for any unpaid subscriptions. In the event of an A Class Share or Corporate Share, the amount being no greater than the value of a Social/Clubhouse subscription amount. In the event of a Golf Class Share this amount being no greater than the value of a Full Membership subscription.
5. Leasees must attend a Club Orientation day before being eligible to win any Major Club event.

PRIVACY STATEMENT

The Company and the Club are subject to the Privacy Act 1998. The personal information you provide when you apply to be a Member of the Club is used to maintain your Membership. You have the right to access and correct any of your personal information that the Company or the Club holds about you. The Club and the Company will not usually disclose your personal information to any other organisation or person unless there is a legal requirement to do so. The Club and the Company may disclose your information to third parties that provide services under contract to the Club or the Company. In particular, the Australian Golf Union ("AGU") requires personal information supplied by you on this Application Form for the purposes of Golfink. Your personal information will only be used to provide information to the AGU in accordance with Golfink activity and to provide you with Golfink services. If the requested information is not provided to the AGU you may not be able to obtain Golfink services including an official Australian Handicap.
